



APPENDIX: CLAIMING OF PRIZE

Confirmation to keep or sell the prize

1. The winner must inform Tan Chong Motor Sales if he/she intends to keep the prize or sell it.
2. Should the winner decide to keep the prize, he/she would have to bid for COE and register the car before the car is released.
3. Should the winner decide to sell the car, he/she must source for own buyer or dealer.
 - The winner and buyer must arrange a meeting with a Tan Chong Motor Sales representative for a transfer of documentation.
 - The winner will have to bring his/her IC, winner's letter and Document of Transfer.
 - The buyer would have to bring his/her IC.
 - A Tan Chong Motor Sales representative will be present to witness the signing of the transfer of documentation. The buyer will proceed to bid for COE.

Bidding for COE

The winner/buyer may bid for his/her own COE. Upon successful bidding, Tan Chong Motor Sales will proceed with registration of the vehicle with the following documents:

1. Winner's letter
2. Photocopy of his/her IC
3. Printout of bidded COE document
4. Insurance cover note
5. Document of transfer (if applicable)

Following which, the winner or buyer will need to come down to Tan Chong Motor Sales, to sign a contract and pay off the balance involved in the registration of the car

1. Road tax (6 months): with effect from 1 January 2024;
 - \$387 for Nissan Kicks e-POWER Premium
 - \$460 for Nissan Serena e-POWER 7s Single Tone
 - \$489 for Nissan Leaf*

** The Annual Flat Component for an Electric Vehicle (EV), in addition to the road tax, is \$700 per year.*
2. In-vehicle unit (IU): \$403.30 (subject to GST)
3. License plate: \$35 (subject to GST)
4. Registration fee: \$350 (subject to GST)
5. Insurance (if purchased through Tan Chong Motor Sales)

Upon successful bidding for COE, the car can be collected in approximately two weeks' time. The winner or buyer will be notified by Tan Chong Motor Sales.

Purchase of Nissan-approved electric vehicle (EV) charger

If a charger is required for the purpose of charging the vehicle, we would encourage the winner or the buyer to purchase a Nissan-approved AC wallbox EV charger that complies with the safety requirements of TR25:2022 set by the Energy Market Authority.

1. The cost of the EV charger is **\$3,000 (exclusive of GST and installation charges)** and is to be borne by the winner of buyer.
2. A site survey will need to be conducted by a Nissan-approved vendor to assess the suitability of installation of the AC wallbox EV charger at the winner's or buyer's preferred site. This site survey is conducted at no cost IF the EV charger is purchased from the Nissan-approved vendor.
3. The cost for installation of the AC wallbox EV charger depends on the complexity of the site. Installation cost is to be borne by the winner or buyer.
4. If the winner or buyer chooses not to purchase the charger, he/she must sign a form to indemnify Tan Chong Motor Sales Pte Ltd and Nissan Motor Co. Ltd from any EV battery, charging systems and electrical systems related claims.

Other Information

1. The vehicle warranty period for Nissan Kicks e-POWER, Nissan Serena e-POWER and Nissan LEAF is 3 years (factory) + 2 years (Infiniti-shield Motor Protection Programme) (Unlimited mileage).
2. The electric vehicle battery warranty period for the Nissan LEAF is 8 years or 160,000km, whichever comes first.
3. The hybrid vehicle battery warranty period for the Nissan Kicks e-POWER and Nissan Serena e-POWER is 10 years or 160,000km, whichever comes first.
4. The prizes (Nissan Kicks e-POWER Premium, Nissan Serena e-POWER 7s Single Tone, Nissan LEAF) cannot be changed to other Nissan models.
5. The colour of the vehicle may vary from advertising materials and will be specified in the winner's letter. The specified colour is fixed and cannot be changed.
6. The winner or buyer can add on accessories to the prize at his/her own expense.
7. The prize is non-refundable and non-exchangeable for cash, credit, goods or benefits in kind.
